#### <u>Track</u>

#### **Track Entry Mid-Ohio Rule**

Be prepared to give a completed Medical Assessment Form to the security guard (will be required for everyone entering the track the first time - form will be emailed to you prior to the event). Your temperature will then be taken and noted on the medical form. If you are under 100.4, you will be allowed to enter the facility. Each time you leave the track and return, your temperature will again be taken, and you will need to be under 100.4 each time to re-enter the facility. Allow for extra time when you come to the track for this process to occur.

#### <u>Staging</u>

Those arriving early will be able to park outside the gates below Registration. Staging will be in the field adjacent to Registration.

#### <u>Gate</u>

Gate 3 is for participants with credentials and where registration is located.

#### <u>Load-In</u>

It is planned that Initial Load-In will begin on Wednesday, J une 24th at appx **4:00PM**. Please note that due to the track being rented on Wednesday, some paddock areas will not be accessible until later in the day. We will load-in each area as soon as it is accessible to us. Other groups racing with us at this event will have different load-in times, so be prepared to see vehicles moving in during staggered times.

#### Personal Vehicle Parking

No personal vehicles will be allowed in the paddock. Space will be limited. Please park in the grass area located directly behind the paddock.

#### <u>Fuel info</u>

Sunoco, the official racing fuel of SVRA, will be available at the Sunoco pumps in the main paddock. They will carry CAM 2 leaded 110, Cam 2 unleaded 100, 260 GTX unleaded non ozygenated 98, and premium unleaded 93.

#### Golf Cart Rentals

National Carts (800-940-8068) All rented and personal <u>golf carts will require a Mid-Ohio sticker</u>. See details at the end of this document. No sticker will be needed for scooters or pit carts.

<u>Power</u>

No power is available in the paddock area. Generators can be rented through United Rentals (Dawson Jones at 216-287-2975)

<u>Pets</u>

Mid-Ohio Sports Car Course does not encourage bringing pets to the track, but they are allowed if kept on a leash.

<u>Load out</u> All rigs have until 7PM on Sunday to be out of the paddock.

All golf carts, scooters and other similar motorized vehicles driven on site must be pre-registered and require a permit, whether owned or rented. Any vehicle on site without proper permit is subject to impound at owner's expense. Permits for approved users will be distributed and/or available for pick-up at the *Mid-Ohio Call Center located behind the Registration building at Gate 3.* 

In order to reserve your permit, the following documents must be completed and submitted by Friday, June 19<sup>th</sup>, 2020:

- Completed and Signed Motorized Vehicle Registration Application (attached)
- Certificate of Insurance, as per application
- Payment of \$100.00 via credit card or check payable to Mid-Ohio Sports Car Course for golf cart stickers only

Note: any application after Friday, June 19th, 2020 is subject to an additional \$25.00 fee.
