#### COVID

VIR has a mask requirement in effect for this event and a COVID Health form that must be signed and handed in at the Security Gate the first time you enter the track. The form is at end of this document. VIR will be taking temperatures at the gate. Your temperature must be under 100.4 to be admitted. Social Distancing should be practiced whenever possible. Masks and hand sanitizer will be located at Registration and Tech.

<u>Truck Route</u>

From HWY 62, turn onto Dotmond Road. Go to end of road to stop sign and then drive directly across to Pine Tree Road and VIR entrance.

<u>Load-in</u>

Scheduled for shortly after Registration opens on Wednesday, September 23<sup>rd</sup> at 3:00PM and will close for the night at 7:00PM. Escorted load-in will resume at 7:00AM Thursday am.

434-882-7700 or <u>http://virnow.com/lodging/camping/</u>Staying overnight will be allowed in your paddock and showers will be open during the event. Camping fees are \$50 per RV and \$30 per tent.

#### <u>Power</u>

Any Participant wanting to use a VIR receptacle for electricity must pay a **\$30fee** per Event which can obtained at the VIR Administration Office. Participants are issued a specific Power Band for the weekend. The Power Band will be secured around the electrical cord end that plugs into the power source.

#### **Garages**

Are available through VIR (434-822-7700 x0 or x300).

#### Shorts in the pit lane

Are allowed except during the Enduros and Trans Am sessions

#### **Golf cart credentials**

Golf carts may be rented from National Golf Carts at nationalcarts.com.

ATVs, golf carts and other off-road vehicles must be licensed by VIR. They must have lights and minibikes must have a minimum seat height of 21 inches. Owners can purchase a license/permit for a fee of \$30, which is valid for the current season. #### <u>Tires</u>

Participants may order race tires for at track delivery mounting and balancing from Sasco Sports (434-822-7200 or <u>dave@sascosports.com</u>).

#### Sunoco Fuel

93 unleaded, 98 (260GTX unleaded), 100 unleaded and 110 leaded will be available from the track fuel pumps at the fuel island. Sunoco Supreme 112 will be dispensed from a truck at the same location. Your on-site contact will be Todd (336-613-6820). Hours are tentatively 7AM – 6PM but check with him on site for any updates to those times. Form of payment is Credit Card only (Visa, MC, and Amex).

#### Fluid Waste Disposal

Waste fluids may be dumped in the labeled containers next to the fuel depot. VIR does not accept Chlorinated Brake Cleaner on property. If you have questions, please contact Kerrigan Smith at 4334-0822-3108.

Acknowledge that I am aware that by entering the premises and participating in the EVENT(S) that there are risks to me and to those with whom I interact of exposure, directly or indirectly, to communicable disease(s) including but not limited to the virus "severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2)", "COVID-19" and/or any mutation or variation thereof;

HEREBY voluntarily agree to RELEASE, WAIVE, DISCHARGE and COVENANT NOT TO SUE on behalf of myself or on behalf of others with whom I interact, the promoters, participants, racing associations, sanctioning organizations or any subdivision thereof, track operators, track owners, officials, competition vehicle owners, drivers, pit crews, rescue personnel, any persons in any RESTRICTED AREA, promoters, sponsors, advertisers, owners and leasees of premises used to conduct the EVENT(S), premises and event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and each of them, their directors, officers, agents and employees, all for the purposes herein referred to as "Releasees", from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefor, whether caused by the negligence of the Releasees or otherwise;
