Staging/Load In

We will be using staggered start times for load-in this year, on Wednesday June 23rd. Please do not arrive more than 2 hours before your move in time. FR and F4 will start at 7:00 AM, followed at 8:30-11:30 by all garage tenants. All remaining SVRA and IGT teams will begin to move at 12:00. You will enter at Gate 3 where Registration is located. Thursday Test day Trans-Am teams will load in starting at 2:30. All other Trans-Am teams will load in on Thursday.

Gate

Gate 3 is for participants with credentials and where registration is located. 24-hour security and access.

Personal Vehicle Parking

No personal vehicles or Motorcoaches not towing a trailer, will be allowed in the paddock. Space will be extremely limited. Please park in the grass area located above the upper paddock. Signage will guide you to this location. There is almost no power in the Mid-Ohio paddock, or parking lots.

Fuel info

110 leaded and 100 unleaded fuel will be available straight at the pump with 24-hour sales, by credit card only. Sunoco Supreme will be dispensed from drums at the garage facility next to the fuel island.

The SVRA and IGT driver's meeting will be sent to you virtually. You will receive a email notification to view. These meetings are specific to each track and vary for each race. A rebroadcast of the meeting will run all day at tech on Thursday in garage #8.

All golf carts, scooters and other similar motorized vehicles driven on site must be pre-registered and require a permit, whether owned or rented. Any vehicle on site without proper permit is subject to impound at owner's expense. Permits for approved users will be distributed and/or available for pick-up at the *Mid-Ohio Call Center located behind the Registration building at Gate 3.*

In order to reserve your permit, the following documents must be completed and submitted by **Friday, June 18th, 2021:**

- Completed and Signed Motorized Vehicle Registration Application (attached)
- Certificate of Insurance, as per application
- Payment of \$100.00 via credit card or check payable to Mid-Ohio Sports Car Course for golf carts only

Note: any application after Friday, June 18th, 2021 is subject to an additional \$25.00 fee.
