**Staging/Load-In**

**GARAGE TENNANTS**

Enter at Gate 2 off County Rt 16. Go right immediately past the gate to stage on Canandaigua road. Line up 2 wheels off the road on driver's left. (Trans-Am will be on the right). At approx. 7:00 AM we will begin to move the line. Teams will turn left onto Seagraves road, and follow to the next intersection, where you will be directed into the garage paddock, for garage parking.

**MAIN PADDOCK SVRA AND IGT COMPETITORS**

Follow on County Rt 16 past gate 2 up the hill to Bronson Hill road. Turn left in front of registration, and turn left again into the large staging lot. Pull down all the way to the end of the lot, and stop. Return to the registration building to register. At 8:00 AM we will begin moving the line. Turn right out of the lot, and cross the track. Follow Seagraves Road, two intersections to the location where SVRA Marshalls will direct you into the lot, and you will be escorted to your space. See the test day schedule for more details.

**Registration**

Registration will be at the WGI Registration Building on Old Bronson Hill Rd and County Rt 16.

**NOTE: Everyone must go to Registration at this event. WGI requires their event waiver to be signed at each event.**

**NO EXCEPTIONS.** Registration will be open Tuesday Sept. 7<sup>th</sup> from 2:00 PM to 5:00PM No track entry. Registration will continue on Wednesday at 7:00AM to 5:00 PM.

**Testing**

SVRA test day sessions will be held on Wednesday starting at 1:00 PM, ending at 4:50. Then resuming again at 8:00 AM Thursday, and ending at 11:50.

### **Garages**

AS of July 26, all Garages were sold out. There is a waiting list ongoing.

### **RV**

RV spaces can be reserved by contacting Watkins Glen at 607-535-3405, Attn: Cindy Burrows. There are hookups in the Pit Road RV area only. RV servicing can be arranged through Jeff's On-Site Services (607-535-9530)

### **Race Engines**

No running of race engines before 7AM or after 10PM

### **Black Flag Station**

Turn 7B and Start/Finish

Clean and Green NY - They will wash in the staging lanes on Canadaigua Road.

### **Golf Carts**

Personal and rented golf carts must be registered and have a WGI sticker (that can be obtained from Jessica Cramer in the Operations Center in the paddock) if you plan on taking your golf cart out of the paddock. Proof of Insurance is required and is available through [kathy@svra.com](mailto:kathy@svra.com) or SVRA at Registration if your personal coverage does not meet their requirements. ### **Fluid Waste Disposal**

Fluid disposal containers are located near the track gas pumps

### **Animals**

Pets are allowed in the campground area. Pets must be on a 6' leash at all times. Owners must clean up after their pets

### **Concession Stands**

Several locations in the paddock near the vendor area

### **Load Out**

**The paddock must be cleared out by Sunday night. Rigs may be left overnight in the staging lot across from Registration until 8:00PM on Monday**

**Certificate of Insurance Needs  
for  
2021 Golf Cart Permits**

A Certificate of Insurance (COI) that must accompany the golf cart permit request, are required to:

- Include the name of the company that holds a contract with and that will be operating the equipment on the track property as the named insured on the certificate.
- Include comprehensive general liability insurance with limits not less than One Million Dollars (\$1,000,000) per occurrence and Two Million Dollars (\$2,000,000) in the aggregate.
- Certificate holder should be:  
    Watkins Glen International  
    2790 County Route 16  
    Watkins Glen, NY. 14891
- Include in the "Description of Operations" section of the certificate the following appropriate additional insured language:

***"Watkins Glen International, LLC, its parents, subsidiaries, limited liability and affiliate companies, and their respective members, shareholders, officers, directors, agents, employees, sponsors, trustees, receivers, successors, subcontractors and assigns are named as additional insureds. This insurance is primary and non-contributory to any other insurance that may be available to an Additional Insured."***

**NOTES**

- A proper COI must be provided to Jessica Cramer for approval before Golf Cart Applications are processed.
